**RELEASE OF SECURITY INTEREST  
IN TRADEMARK**

WHEREAS, Package Machinery Company, Inc. f/k/a PMC Acquisition Corporation, a Massachusetts Corporation having a principal place of business at 80 Commercial Street, Holyoke, Massachusetts (the "Mortgagor") is the owner of the trademark listed on Schedule A attached hereto, which mark is registered in the United States Patent and Trademark Office as set forth on Schedule A attached hereto ("Trademark"); and

WHEREAS, the Mortgagor entered into the Patent Collateral Security and Pledge Agreement (as amended, modified, restated or supplemented from time to time, the "Security Agreement"), dated as of July 24, 1996, in which the Mortgagor has agreed with TD Bank, N.A. f/k/a First Massachusetts Bank, N.A., successor by merger to Family Bank, FSB, having a principal place of business at 1441 Main Street, Springfield, Massachusetts, as Mortgagee (the "Mortgagee") to execute this Release of Security Interest;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, as security for the payment and performance of the Fourth Modification of Patent Collateral Security and Pledge Agreement dated as of October 5, 2000, the Mortgagee releases the security interest in all of its right, title and interest in and to the Trademark, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademark. This Release has been given in conjunction with the assignment and security interest granted to the Mortgagee under the Security Agreement, and the provisions of this Assignment are without prejudice to and in addition to the provisions of the Security Agreement, which are incorporated herein by this reference.
