TERMINATION OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, the Secured Party has agreed to terminate and release its security interest in all of the Trademarks.

NOW, THEREFORE, for valuable consideration, the Secured Party hereby terminates and releases all security interests in the Trademarks previously granted to the Secured Party.
