**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY FOR TERM A  
AND TERM B**

**THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY FOR TERM A AND TERM B** (this "Release") is made as of June 25, 2010 ("Effective Date") by and between Arrow Group Industries, Inc., a Delaware Corporation ("Arrow"), Arrow Group Industries, Inc.-Europe, a Delaware corporation ("Arrow Europe," and collectively with Arrow, the "Grantors"), and Wells Fargo Bank, National Association, as (a) collateral agent for the Term A Secured Parties, and (b) collateral agent for the Term B Secured Parties ("Grantee"). Terms defined in the Loan Agreement (as defined below) and not otherwise defined herein are used herein as therein defined.

**WHEREAS**, Arrow, Arrow Holding Corporation, various financial institutions and Grantee are party to that Term Loan Agreement, dated as of March 29, 2005 (the "Loan Agreement");

**WHEREAS**, pursuant to the terms and conditions of that certain Security Agreement between Grantors and Grantee dated March 29, 2005 (the "Security Agreement"), Grantors granted to Grantee (as the collateral agent for the Term A Secured Parties and collateral agent for the Term B Secured Parties) a continuing security interest in all of Grantors' rights, title and interest in, to and under, among other things, certain trademarks, patents and copyrights, including some or all of the Purchased Assets (as that term is defined in that certain Master Settlement and Release Agreement dated June 25, 2010 (the "Master Settlement and Release Agreement")) set forth on Schedule A, to secure prompt payment or performance in full when due of all Term A Loan Obligations and prompt payment or performance when due of all Term B Loan Obligations;

**WHEREAS**, the Security Agreement was recorded with the United States Patent and Trademark Office; and

**WHEREAS**, Grantee, in its duly authorized capacity as the collateral agent for the Term A Secured Parties and the Term B Secured Parties has agreed to release its security interest in the Purchased Assets pursuant to the Master Settlement and Release Agreement;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee, in its duly authorized capacity as the collateral agent for the Term A Secured Parties and the Term B Secured Parties, hereby cancels and releases any and all security interests it has against the Purchased Assets set forth on Schedule A.

Grantee shall, at Grantors' expense, take all further actions, and provide to Grantors, Grantors' successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Release.

This Release is subject to all the terms and conditions of the Master Settlement and Release Agreement and is intended to carry out the intent set forth in the Master Settlement and Release Agreement.

This Release is intended to be recorded in the U.S. Patent and Trademark Office or any other U.S. or foreign government trademark office(s) as desired to confirm and evidence the foregoing release and termination of the security interest and rights created under the Security Agreement with respect to the Purchased Assets set forth on Schedule A.
