RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Release") is dated on NOVEMBER 5, 2015, by PNC BANK, NATIONAL ASSOCIATION (the "Agent").

BACKGROUND

A. BRLI No. 2 Acquisition Corp. (now known as GeneDx, Inc. ("Grantor")) executed and delivered to Agent that certain Intellectual Property Security Agreement dated as of October 31, 2006 (the "IP Security Agreement"), which granted to Agent a lien and security interest in and to all of the Grantor's Trademarks and Trademark Licenses as more particularly defined and described in the IP Security Agreement (the "Trademark Collateral") as security for some or all of the Grantor's obligations to the Agent and the Lenders (as defined in the IP Security Agreement) for one or more loans or other extensions of credit.

B. The IP Security Agreement was recorded in the United States Patent and Trademark Office on December 19, 2006, in Reel 3447, Page 326.

RELEASE

The undersigned, on behalf of Agent, hereby certifies that the non-contingent obligations secured by the Trademark Collateral have been paid in full and the security interests granted by the Grantor to Agent in the Trademark Collateral may now be released. The Bank hereby releases its security interests in and liens on the Trademark Collateral described in and created by the IP Security Agreement. The IP Security Agreement may now be released of record.
