**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of October 22, 2015 ("Effective Date") by and between **BANK OF AMERICA, N.A.**, a national banking association, with an office at 400 4th Street, Lake Oswego, OR 97034 ("Grantee"), and **BI-MART CORPORATION**, a California corporation, with an office at 220 S. **NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the security agreement recorded on September 2, 2011, at Reel 4617, Frame 0207.

At the request of Grantor, at Grantor's expense, Grantee agrees to execute and deliver such other and further documents and instruments reasonably acceptable to Grantee, as may be reasonably requested in order to effect or evidence more fully the matters covered by this Release.
