SUPPLEMENT TO TRADEMARK SECURITY AGREEMENT

This Supplement to Trademark Security Agreement (this "Supplement"), dated as of November 9, 2015, is delivered pursuant to (a) the Credit Agreement, dated as of March 15, 2006 (as amended, restated, modified or supplemented from time to time, the "Credit Agreement"), by and among the financial institutions party thereto (such financial institutions, together with their respective successors and assigns, are referred to hereinafter each individually as a "Lender" and collectively as the "Lenders"), WELLS FARGO CAPITAL FINANCE, INC. (f/k/a Wells Fargo Foothill, Inc.), a California corporation, as arranger and administrative agent for the Lenders (in such capacities, together with any successor arranger and administrative agent, "Agent"), and JENZABAR, INC., a Delaware corporation (the "Borrower"), and (b) the Trademark Security Agreement, dated as of March 14, 2006 (as amended, restated, modified or supplemented and in effect from time to time, the "Trademark Security Agreement"), by and between the Borrower and Campus America-Tulsa, Inc., an Oklahoma corporation (each a "Grantor" and, collectively, the "Grantors") and the Agent, which was recorded with the United States Patent and Trademark Office on April 5, 2006 at Reel 3283/Frame 0223. The undersigned hereby agrees that this Supplement may be attached to the Trademark Security Agreement and made a part thereof. Capitalized terms used herein and not otherwise defined herein shall have the respective meanings provided therefor in the Trademark Security Agreement.


