**SECURITY INTEREST
IN PATENTS AND TRADEMARKS**

THIS SECURITY INTEREST IN PATENTS AND TRADEMARKS (this "**Security Interest**"), effective as of November 19, 2015, is made to secure the satisfactory performance and payment of all the obligations of Grantor under the Third Amended and Restated Note Purchase Agreement dated as of February 23, 2015, among the Grantor, the Grantees and the other parties thereto (as amended, modified or supplemented from time to time, the "**Agreement**") and the secured promissory notes issued thereunder.

This Security Interest has been granted in conjunction with the security interest granted to the Grantees under the Agreement. The rights and remedies of the Grantees with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Security Interest are deemed to conflict with the Agreement, the provisions of the Agreement shall govern.
