RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of November 30, 2015 (this "**Release**"), by JPMORGAN CHASE BANK, N.A., ("**JPMCB**"), as Collateral Agent. Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Security Agreements, as applicable, referred to below.

A. Reference is made to (i) the Credit Agreement dated as of August 11, 2005, as amended and restated as of June 9, 2009, as further amended by the First Refinancing Amendment dated as of January 31, 2011, as further amended by the Second Refinancing and Incremental Amendment dated as of March 11, 2011, as further amended by the Third Amendment dated as of November 10, 2011, as further amended and restated by the Fourth Amendment dated as of March 2, 2012, as further amended and restated by the Fifth Amendment dated as of December 17, 2012, as further amended and restated by the Sixth Amendment dated as of March 8, 2013, and as further amended by the Seventh Amendment dated as of February 7, 2014 (as further amended, restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), among SunGard Data Systems Inc. (the "**Company**"), SunGard Holdco LLC ("**Holdings**"), the Lenders from time to time party thereto and JPMCB, as Administrative Agent, (ii) the Security Agreement dated as of August 11, 2005 (as amended, restated, supplemented or otherwise modified from time to time), among Holdings, the Company, Solar Capital Corp., the other Subsidiaries from time to time party thereto and JPMCB, as Collateral Agent and (iii) the Intellectual Property Security Agreement dated as of August 11, 2005 (as amended, restated, supplemented or otherwise modified from time to time), among Holdings, the Company, Solar Capital Corp., the other Subsidiaries from time to time party thereto and JPMCB, as Collateral Agent (the documents set forth in clauses (ii) and (iii), the "**Security Agreements**").

B. Pursuant to the Security Agreements, the Grantors granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all right, title and interest of such Grantors in, among other things, the Trademarks set forth on Schedule I hereto (the "**Trademark Collateral**"), which security interests were recorded with the United States Patent and Trademark Office on January 14, 2008 in Reel 3695, Frame 420.

C. Pursuant to the Payoff Letter dated as of November 30, 2015 among the Company, Holdings and JPMCB, JPMCB acknowledges that any and all security interests it may have in the Trademark Collateral pursuant to the Security Agreements have been automatically released.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby release, relinquish, discharge and terminate any and all security interests it has relating to the Trademark Collateral and the Company's right, title and interest in or to the Trademark

Collateral. This Release is made without representation or warranty by, or recourse to, the Collateral Agent or any other Secured Party.


The Collateral Agent, on behalf of the Secured Parties, hereby reassigns to the Company all of the Collateral Agent's or Secured Parties' right, title and interest in and to the Trademark Collateral.

The Collateral Agent understands and agrees that this Release may be recorded by or for the Company or the Company's successor in interest with the U.S. Patent and Trademark Office or any other similar office or governmental agency of any other country or territory. The Collateral Agent further agrees, at the sole cost and expense of the Company, to perform all acts reasonably necessary to effect the release and termination of its security interest and liens, including, but not limited to, the recording, filing and entering into any agreements, documents, forms or papers reasonably required to accomplish such release and termination.
