TERMINATION AND RELEASE OF TRADEMARK AND PATENT SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK AND PATENT SECURITY AGREEMENT (this "Termination"), is dated as of November 24, 2015, and made by **PNC BANK, NATIONAL ASSOCIATION**, in its capacity as Agent under the below-defined Security Agreement ("Grantee") to **UST GLOBAL, INC.**, a Delaware corporation ("Grantor").

WHEREAS, pursuant to that certain Trademark and Patent Security Agreement dated as of December 6, 2012, made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademark / Patent Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark and Patent Division of the United States Patent and Trademark Office on April 15, 2013, at Reel 5006 and Frame 0719; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Trademark / Patent Collateral," as used herein, shall mean the Trademarks and Patents set forth in the Security Agreement and shall include all of the Grantor's right, title and interest in all of Grantor's trademarks, trademark applications, patents and patent applications, (such trademarks and trademark applications, the "Trademarks" and such patents and patent applications, the "Patents"), including but not limited to those Trademarks and Patents listed on Schedule I annexed hereto, and all reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark, and all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark or Patent, or (b) injury to the goodwill associated with any Trademark.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademark / Patent Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademark / Patent Collateral.
