## TERMINATION OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION OF TRADEMARK SECURITY AGREEMENT is made and entered into as of the date shown below by BANK OF AMERICA, N.A. (the "Bank") in favor of GRAHAM CORPORATION (the "Borrower").

The Bank represents and warrants that (i) it has the full power and authority to execute this instrument and (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest provided to them pursuant to the above referenced security agreements.
