**RELEASE OF SECURITY INTEREST OF  
TRADEMARKS AND TRADEMARK APPLICATIONS (“Release”)**

**November 23, 2015**

Reference is hereby made to that certain Trademark Security Agreement, dated as of June 30, 2011 (the “Agreement”), executed by AXS-One, Inc., a Delaware corporation (the “Corporation”) whose address is 600 E. Las Colinas Blvd., Suite 1500, Irving, TX 75039, in favor of Wells Fargo Capital Finance, LLC, in its capacity as Agent (as defined in the Agreement), a Delaware limited liability company (“Agent”) whose address is 2450 Colorado Avenue, Suite 3000, West Santa Monica, CA 90404, which was recorded in the United States Patent and Trademark Office on July 15, 2011 at Reel 004584, Frame 0361, pursuant to which the Corporation assigned, pledged and granted to the Agent a continuing security interest in and to all of the Corporation's right, title and interest in and to the Trademark Collateral (as defined in the Agreement), including those trademarks and trademark applications specifically listed on Exhibit A attached hereto, the right to receive all products and proceeds therefrom and the goodwill associated therewith, in each case arising under the Security Agreement (as defined in the Agreement) and the Agreement (collectively, the “Marks”);

WHEREAS, the Secured Obligations (as defined in the Security Agreement) have been paid in full and Agent wishes to terminate the Agreement and release said security interest in and to the Marks to the Corporation and, without representation or warranty, all of Agent's right, title and interest in and to the Marks and the goodwill associated therewith, to the Corporation;


WHEREAS, after the date of the Agreement, the Corporation subsequently merged with and into Daegis Inc., a Delaware corporation (the “Borrower”);

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Agent hereby terminates and cancels the Agreement and absolutely, unconditionally and irrevocably, releases, terminates and forever discharges each security interest in and to the Marks and the Trademark Collateral that was granted under the Agreement, and any and all other security interests or liens that the Agent may have in or to the Marks or the Trademark Collateral and the goodwill associated therewith. The parties hereto authorize and request the Director of Patents and Trademarks of the United States of America to record this Release against the Marks.
