PATENT AND TRADEMARK SECURITY AGREEMENT
(Mitek Corporation)

THIS PATENT AND TRADEMARK SECURITY AGREEMENT ("Abridged Security Agreement") is made and entered into as of September 30, 2015, by MITEK CORPORATION, an Illinois corporation ("Grantor"), whose address is One Mitek Plaza, Winslow, IL 61084, in favor of BMO HARRIS BANK N.A. ("Bank"), whose address is One West Main Street, Madison, WI 53703.

RECITALS

- (a) This Abridged Security Agreement is executed pursuant to the Intellectual Property Security Agreement, dated contemporaneously herewith, between Grantor and Bank (as it may be restated, modified, amended, or replaced from time to time, the "IP Security Agreement"), and the Credit Agreement.
- (b) Bank has agreed to make available to Grantor, subject to the Credit Agreement, certain revolving loans, which are evidenced by the Note, and Grantor has agreed to provide certain Pledged Collateral to secure the Obligations, all on the terms and conditions set forth in the Credit Agreement, the IP Security Agreement, and the other related Loan Documents.
- (c) The terms and conditions of the IP Security Agreement include the execution, delivery and recordation of this Abridged Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

AGREEMENT

1. Supplement to IP Security Agreement. This Abridged Security Agreement has been entered into in conjunction with the security interest granted by Grantor to Bank under the IP Security Agreement. The terms of this Abridged Security Agreement are supplemental to and not in replacement of the terms of the IP Security Agreement, and the rights and remedies of Bank with respect to the security interest granted herein are without prejudice to, but in addition to, those set forth in the IP Security Agreement. If there is any conflict between this Abridged Security Agreement and the IP Security Agreement, the IP Security Agreement shall govern.

2. Security Interest and Collateral. To secure the payment and performance of all of the Obligations, Grantor grants Bank a security interest in all of Grantor's present and future rights and interest in the Patents and Trademarks identified on Schedule A and Schedule B, respectively, to this Abridged Security Agreement.

3. General Provisions. Sections 11. through 17. of the IP Security Agreement are incorporated herein by reference, except that the term "Security Agreement" as used in Sections

11. through 17. of the IP Security Agreement will mean this Abridged Security Agreement.

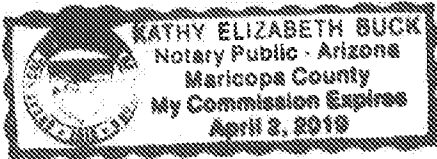
