**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (the “Release”) is executed as of December 14, 2015, by **BANK OF AMERICA, N.A.**, as Collateral Agent for the Secured Parties under the Credit Agreement referred to below (in such capacity, the “Collateral Agent”), in favor of Interactive Data Online Properties, Inc., Interactive Data Corporation, Interactive Data Pricing and Reference Data, LLC and BondEdge Solutions LLC (the “Grantors”). Capitalized terms used herein and not otherwise defined herein shall have the respective meanings provided therefor in the Credit Agreement referred to below.

WHEREAS, the Grantors entered into (i) that certain Credit Agreement dated as of May 2, 2014 (as amended, amended and restated, or otherwise modified to the date hereof, the “Credit Agreement”), and (ii) that certain Collateral Agreement dated as of May 2, 2014 (as amended, amended and restated, or otherwise modified to the date hereof, the “Collateral Agreement”), each agreement among Igloo Intermediate Corporation, a Delaware corporation, Interactive Data Corporation, a Delaware corporation, the Lenders party thereto and Bank of America, N.A., as Administrative Agent and Collateral Agent;

WHEREAS, pursuant to the Credit Agreement and the Collateral Agreement, the Grantors and the Collateral Agent executed (w) a Trademark Security Agreement dated as of May 2, 2014 (as amended, amended and restated, or otherwise modified to the date hereof, the “IDOP Trademark Security Agreement”) among Interactive Data Online Properties, Inc. and the Collateral Agent, (x) a Trademark Security Agreement dated as of May 2, 2014 (as amended, amended and restated, or otherwise modified to the date hereof, the “IDC Trademark Security Agreement”) among Interactive Data Corporation and the Collateral Agent, (y) a Trademark Security Agreement dated as of May 2, 2014 (as amended, amended and restated, or otherwise modified to the date hereof, the “IDPR Trademark Security Agreement”) among Interactive Data Pricing and Reference Data, LLC and the Collateral Agent and (z) a Trademark Security Agreement dated as of May 2, 2014 (as amended, amended and restated, or otherwise modified to the date hereof, the “BE Trademark Security Agreement” and, together with the IDOP Trademark Security Agreement, the IDC Trademark Security Agreement and the IDPR Trademark Security Agreement, the “Trademark Security Agreements”) among BondEdge Solutions LLC and the Collateral Agent, and pursuant to the Collateral Agreement and the Trademark Security Agreements the Grantors granted to the Collateral Agent, among others, a continuing security interest in all of the Grantors’ right, title and interest in and to all Trademarks owned or acquired by such Grantors, including without limitation those listed on Exhibit A hereto, and all goodwill associated therewith and all rights to sue or otherwise recover for any past, present, or future infringement or other violation or impairment of any of the foregoing (such security interest, the “Security Interest”, and all such Trademarks, goodwill and other rights, collectively, the “Trademark Collateral”);

WHEREAS the IDOP Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 6, 2014 at Reel 5274, Frame 0247, the IDC Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 6, 2014 at Reel 5274, Frame 0237, the IDPR Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 6, 2014 at Reel 5274, Frame 0252, the IDPR Corrective Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 14, 2014 at Reel 5280, Frame 0014, and the BE Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 6, 2014 at Reel 5274, Frame 0232; and


WHEREAS the Collateral Agent has agreed to terminate and release its Security Interest as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, (i) the Collateral Agent hereby irrevocably releases, terminates and discharges the Security Interest, (ii) any right, title or interest of the Collateral Agent in or to the Trademark Collateral shall hereby terminate, cease and become void, and (iii) the Collateral Agent hereby irrevocably assigns to the Grantors any right, title and interest it may have in the Trademark Collateral. The Collateral Agent hereby consents to the recording of this Release with the United States Patent and Trademark Office and agrees to duly execute and deliver any further documents and do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
