## AUTHORIZATION & DIRECTION

OSMINGTON INC. (the “**Secured Party**”) hereby authorizes and directs the law firm of Thompson Dorfman Sweatman LLP, or its agents in jurisdictions other than Manitoba, if required, to discharge all security granted by Farmers Edge Inc. 3. to file Discharge Statements in the PPR of Alberta to discharge the following PPR registrations:
  - (a) PPR Registration No. 15071618728 registered by the Secured Party against the Debtor;
  - (b) PPR Registration No. 15071618468 registered by the Secured Party against 598;
  - (c) PPR Registration No. 15071618565 registered by the Secured Party against 619;

5. to file discharges or such other documents as may be required to remove the Notices of Security Agreement filed in the Canadian Intellectual Property Office against the Debtor's Canadian intellectual property pursuant to an Intellectual Property Security Agreement dated July 17, 2015, between the Debtor and the Secured Party, a copy of which agreement is attached as Schedule "A" hereto;
6. to file discharges or such other documents as may be required to remove the Notices of Security Interest filed in the United State Patent and Trademark Office against the Debtor's United States intellectual property pursuant to an Intellectual Property Security Agreement dated July 17, 2015, between the Debtor and the Secured Party, a copy of which agreement is attached as Schedule "B" hereto; and
7. to do all such other things as may be required to fully discharge the foregoing registrations and any and all other security granted by the Debtor, 598, 619 and GranDuke to the Secured Party pursuant to the Debenture and the documents delivered thereunder (collectively, the "Security")

The Secured Party hereby agrees to execute and deliver such further and other documents as may be required to give full effect to this Authorization & Direction and fully discharge the Security.
