## RELEASE OF TRADEMARK SECURITY AGREEMENT

This Release of Trademark Security Agreement (this "Release") is made as of February 2, 2016, by CADENCE BANK, N.A., a national banking association, Lender under (and as defined in) the Trademark Security Agreement referred to below (the "Lender") for the benefit of UNIRUSH, LLC, a Delaware limited liability company (the "Grantor"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Trademark Security Agreement.

### W I T N E S S E T H:

WHEREAS, the Grantor and the Lender are parties to that certain Trademark Security Agreement dated as of January 8, 2015 (as amended, restated or otherwise modified through the date hereof, the "Trademark Security Agreement"), pursuant to which the Grantor has granted to the Lender for its benefit, a security interest in the Trademark Collateral (as defined therein), including those trademarks set forth on Schedule I hereto;

WHEREAS, reference is made to the Loan Agreement dated as of January 6, 2015 (as amended, supplemented or otherwise modified from time to time, the "Loan Agreement"), among Grantor and the Lender;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office at Reel 5437 and Frame 0972 on January 9, 2015; and


WHEREAS, Grantor has requested that the Lender release, and the Lender is willing to release its lien on and security interest in, and any other right, title, and interest it may have in, to and under the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby agrees as follows:

1. Capitalized terms used in this Release and not otherwise defined herein have the meanings specific in the Loan Agreement.
2. The Lender does hereby terminate, release and discharge the entirety of any and all security interests that it may have in the Trademark Collateral and any right, title or interest of the Lender in such Trademark Collateral shall hereby terminate, cease and become void.
3. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of Texas.
