**NOTICE OF RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

WHEREAS, by the Intellectual Property Security Agreement, dated as of April 16, 2013 (the “IP Security Agreement”), recorded in the United States Patent and Trademark Office at Reel/Frame 5008/0340, REX 2010, LLC, a Florida limited liability company (the “Grantor”), assigned to and granted to BANK OF AMERICA, N.A., as administrative agent and collateral agent (in such capacity, the “Administrative Agent”), a security interest in all right, title and interest of the Grantor in and to, among other collateral, the trademarks listed on Schedule A hereto (the “Released Trademarks”); and


WHEREAS, pursuant to that certain Confirmation of Partial Release, dated [January 18, 2016], among the Administrative Agent and Cenveo Corporation, the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Released Trademarks.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the Administrative Agent hereby relinquishes, releases and discharges its security interest in all right, title and interest in and to the Released Trademarks, and hereby reassigns, grants and conveys to Grantor any and all of the Administrative Agent’s right, title and interest in and to such Released Trademarks. This Notice of Release of Security Interest in Trademarks is applicable only with respect to the Released Trademarks and is not applicable to any other collateral assigned or granted under the IP Security Agreement (the “Retained Collateral”). The Administrative Agent retains all security interests, liens, rights, titles and interests pledged and granted to the Administrative Agent under the IP Security Agreement with respect to all such Retained Collateral, and the Administrative Agent’s security interest, liens, rights, titles and interests in such Retained Collateral shall not be impaired, interrupted or otherwise modified in any respect by this Notice of Release of Security Interest in Trademarks.
