TERMINATION OF TERM LOAN PLEDGE AND SECURITY AGREEMENT

This TERMINATION OF TERM LOAN PLEDGE AND SECURITY AGREEMENT, dated as of February 8, 2016, is made by Silver Point Finance, LLC and SummitBridge National Investments LLC (collectively, the "Secured Parties").

WHEREAS, SourceLink Acquisition, LLC (the "Grantor") granted to the Secured Parties a security interest in certain trademarks listed on Exhibit A hereto (the "Trademarks"), pursuant to that certain Term Loan Pledge and Security Agreement dated September 28, 2005, by and between the Grantor and the Secured Parties (the "Security Agreement");

WHEREAS, such security interest granted to the Secured Parties was recorded in the United States Patent and Trademark Office ("USPTO") on October 6, 2005, at Reel 003204 and Frame 0705; and

WHEREAS, the Secured Parties have agreed to terminate the Security Agreement and release their security interests in the Trademarks granted thereunder.

NOW, THEREFORE, for valuable consideration, the Secured Parties hereby terminate and release all liens and security interests in the Trademarks pursuant to the Security Agreement.
