**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of February 16, 2016, and made by **WEBSTER BANK, NATIONAL ASSOCIATION**, a national banking association ("Bank") in favor of the Grantors listed on the signature pages to the Security Agreement (as defined below) (collectively, jointly and severally, "Grantors" and each individually "Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of April 9, 2014, made by the Grantors in favor of Bank (as amended to date, the "Security Agreement"), a security interest was granted by the Grantors to Bank in certain collateral;

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on April 9, 2014; and

WHEREAS, the Bank now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Bank hereby states as follows:

1. Definitions. The term "Trademarks," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks listed on Schedule A hereto.

2. Release of Security Interest. The Bank hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and all other Trademark Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of the Bank in the Trademarks and all other Trademark Collateral.
