**TERMINATION AND RELEASE  
OF TRADEMARK ASSIGNMENT**

THIS **TERMINATION AND RELEASE OF TRADEMARK ASSIGNMENT** (this "Release") dated as of the 16<sup>th</sup> day of February, 2016, by and between **ANTARES CAPITAL LP**, as agent (the "Agent") and **ICON IDENTITY SOLUTIONS, INC.**, an Illinois corporation (the "Company").

**RECITALS**

**WHEREAS**, in connection with the transactions contemplated by that certain Payoff Letter dated February \_\_, 2016 delivered by the Agent to the Company and certain of its affiliates (the "Payoff Letter"), the parties desire to terminate and release the Agent's security interest in, among other things, certain registered trademarks of the Company; and

**WHEREAS**, in order to effect such termination, the Agent desires to release the assignment of those trademarks set forth on **Schedule A** hereto (collectively, the "Assigned IP") pursuant to (i) a Trademark Security Agreement dated July 31, 2007 filed with the United States Patent and Trademark Office (the "USPTO") on August 1, 2007 at Reel 003592, Frame 0710, (ii) a Trademark Security Agreement dated February 12, 2008 filed with the USPTO on April 3, 2008 at Reel 003571, Frame 0698 and (iii) the Trademark Security Agreement dated November 30, 2010, filed with the USPTO on April 7, 2011 at Reel 004517, Frame 0606 (collectively, the "Trademark Assignments") and authorize the reconveyance of the Assigned IP.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

1. **Release and Termination.** The Trademark Assignments are hereby terminated. The Agent further hereby (i) terminates, cancels and releases its security interest in and to the registered patents and trademarks of the Company, including, without limitation, the Assigned IP, and (ii) assigns and transfers to the Company, without representation, warranty or recourse of any kind or nature, all of the Agent's right, title and interest in and to the registered patents and trademarks of the Company, including, without limitation, the Assigned IP. The Company hereby acknowledges and accepts the foregoing release and assignment by the Agent.
2. **Authorization.** The Agent hereby authorizes the Company, at the expense of the Company, to file this Release in the applicable filing and recording offices to effect a complete release of the Assigned IP in accordance with the Payoff Letter.
3. **Governing Law.** This Release will be governed by and construed in accordance with the laws of the State of Illinois, applicable to contracts to be made and wholly performed within such state.
4. **Counterparts.** This Release may be executed in any number of counterparts and by different parties hereto in separate counterparts, each of which shall be deemed to be an original, but all of which taken together constitute one and the same instrument.






