EXECUTION VERSION

**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of February 24, 2016 (this "Release"), is made by PNC Bank, National Association, as collateral agent (in such capacity, the "Agent"), in favor of Shortcake IP Holdings LLC, a Delaware limited liability company ("SIH"), as follows:

W I T N E S S E T H

WHEREAS, American Greetings Corporation ("AGC"), Those Characters From Cleveland, Inc., an Ohio corporation and an indirect wholly-owned subsidiary of AGC ("TCFC"), the Agent and the other parties thereto entered into that certain Credit Agreement on August 9, 2013 (as amended by that certain First Amendment to Credit Agreement, dated as of January 24, 2014, that certain Second Amendment to Credit Agreement, dated as of February 4, 2014 and that certain Third Amendment to Credit Agreement, dated as of September 5, 2014, and as further amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, in connection with the Credit Agreement, AGC granted the Agent (or its predecessor in interest) a security interest in certain collateral pledged by TCFC pursuant to the Trademark Security Agreement, dated as of May 11, 2004, the Collateral Assignment of Trademarks, dated as of April 4, 2006, as amended on June 11, 2010, and the First Amendment to the Amended and Restated Pledge and Security Agreement, dated as of January 18, 2012, which was recorded with the U.S. Patent and Trademark Office on January 28, 2005, November 22, 2006, June 24, 2010 and January 18, 2012 at Reel/Frame No. 3019/0746, Reel/Frame No. 3433/0001, Reel/Frame No. 4230/0765 and 4743/0813, respectively, as further described therein, including, without limitation, the United States trademarks set forth on Schedule A attached hereto (collectively, the "Trademark Collateral");

WHEREAS, pursuant to that certain Asset Purchase Agreement, dated as of February 2, 2015, among TCFC, Iconix Brand Group, Inc., a Delaware corporation ("IBG"), SIH, and Iconix Luxembourg Holdings SÀRL, a Société à responsabilité limitée registered in The Grand Duchy of Luxembourg ("ILH"), TCFC sold, assigned, transferred and conveyed, among other assets, the Trademark Collateral to IBG, SIH and ILH (the "Strawberry Shortcake Sale"); and

WHEREAS, in connection with the Strawberry Shortcake Sale, AGC and SIH have requested that the Agent release its security interest in all right, title and interest of the Agent in and to the Trademark Collateral.

NOW, THEREFORE, the Agent, without recourse, representation or warranty and at SIH's or AGC's sole cost and expense, hereby terminates, cancels and releases any security interest of the Agent in the Trademark Collateral and any all rights, title and interests of the Agent in the Trademark Collateral shall hereby terminate, cease and become void.


