**RELEASE AND TERMINATION  
OF  
TRADEMARK SECURITY AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS, that a certain Amended and Restated Trademark Security Agreement (the "Trademark Security Agreement") was executed by Vistar Corporation (a Colorado corporation), Roma Food Services, Inc. (a Delaware corporation), and the Grantors listed therein (the "Grantors"), covering the Trademark Collateral more fully described on Schedule I annexed hereto and made a part hereof in favor of General Electric Capital Corporation, as Agent (the "Agent"), dated as of September 14, 2005, and recorded with the United States Patent and Trademark Office on September 27, 2005 on Reel 003219 Frame 0770. Capitalized terms used herein and not otherwise defined have the meanings ascribed to them in the Amended and Restated Trademark Security Agreement.

Grantors have requested and the Agent has agreed to terminate and release the entirety of its security interest in the Trademark Collateral and discharge the Amended and Restated Trademark Security Agreement.

For good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release and Termination the Agent hereby states as follows:

The Agent hereby releases all of its right, title and interest in, to and under the Trademark Collateral which were pledged, mortgaged and set over or otherwise made subject to a lien to the Agent and Lenders by Grantors pursuant to the Amended and Restated Trademark Security Agreement and terminates the Amended and Restated Trademark Security Agreement.
