**RELEASE AND TERMINATION
OF
TRADEMARK SECURITY AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS, that a certain Trademark Security Agreement (the "Trademark Security Agreement") was executed by Vistar Corporation (formerly known as Multifoods Distribution Group Inc.) (a Colorado corporation) (the "Grantor"), covering the Trademark Collateral more fully described on Schedule I annexed hereto and made a part hereof in favor of General Electric Capital Corporation, as Agent (the "Agent"), dated as of February 10, 2003, and recorded with the United States Patent and Trademark Office on February 25, 2003 on Reel 002679 Frame 0359. Capitalized terms used herein and not otherwise defined have the meanings ascribed to them in the Trademark Security Agreement.

Grantor has requested and the Agent has agreed to terminate and release the entirety of its security interest in the Trademark Collateral and discharge the Trademark Security Agreement.

For good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release and Termination the Agent hereby states as follows:

The Agent hereby releases all of its right, title and interest in, to and under the Trademark Collateral which were pledged, mortgaged and set over or otherwise made subject to a lien to the Agent and Lenders by Grantor pursuant to the Trademark Security Agreement and terminates the Trademark Security Agreement.
