**DISCHARGE OF SECURITY INTEREST**  
**(Trademarks)**

Dated: April 12, 2016

**WHEREAS**, H & R Accounts, Inc., an Illinois corporation (the "**Grantor**") granted a security interest in the United States Trademarks listed in Exhibit A attached hereto and in the other collateral described in the Security Agreement (as defined below) (collectively, the "**Collateral**") to U.S. Bank National Association, as Administrative Agent (the "**Grantee**"), pursuant to that certain Amended and Restated Pledge and Security Agreement and Irrevocable Proxy (the "**Security Agreement**") dated January 17, 2012, in order to secure repayment of certain amounts owing to Grantee and the other lenders (the "**Lenders**") from time to time party to that certain Amended and Restated Credit Agreement dated January 17, 2012 among the Grantor, the Grantee, and the Lenders, as amended, restated, or otherwise modified from time to time (the "**Credit Agreement**");

**WHEREAS**, a Confirmatory Grant of Security Interests in Trademarks (the "**Confirmatory Grant**") between the Grantor and the Grantee with respect to the trademarks listed in Exhibit A was entered into on January 17, 2012, and was recorded in the records of the United States Patent and Trademark Office (the "**USPTO**") on January 20, 2012, and such recordation is located on Reel 4701 at Frame 0938 of the USPTO; and

**WHEREAS**, the Grantee desires to release the marks listed in Exhibit A from the Confirmatory Grant.

**NOW THEREFORE**, to all who it may concern be it known that for and in consideration of the payment to the Grantee of the full amount of the indebtedness described in the Credit Agreement and Security Agreement, the Grantee hereby (a) terminates, releases and discharges all the security interests granted by the Security Agreement, being the security interests granted in respect of the patents, trademarks, copyrights and all other Collateral and (b) acknowledges, confirms and agrees that the Confirmatory Grant is discharged, released and terminated and of no further force or effect.
