RELEASE OF SECURITY INTEREST  
IN TRADEMARKS

BookMasters, Inc., an Ohio corporation (the "Grantor") executed and delivered a Trademark Security Agreement (the "Agreement") in favor of Gladstone Business Loan, LLC, a Delaware limited liability company and successor-in-interest to Gladstone Capital Corporation (the "Lender"), pursuant to which the Grantor granted to the Lender a security interest in and to all of the Grantor's right, title and interest in and to all of its trademarks and trademark applications and all proceeds thereof, including the specific trademarks listed on Exhibit A attached hereto (the "Released Marks"), and the goodwill associated therewith. The Agreement was recorded in the United States Patent and Trademark Office ("USPTO") at Trademark Reel/Frame Number 5063/0831 (recorded on July 3, 2013).

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Lender, on behalf of itself, its successors, legal representatives and assigns, hereby (i) terminates, releases, and discharges fully its security interest in and to the Released Marks, and the goodwill associated therewith, (ii) waives and relinquishes all its rights, powers, privileges and remedies with respect to the Released Marks, and the goodwill associated therewith, and (iii) reassigns, grants, and conveys to the Grantor any and all right, title and interest it has in the Released Marks, and the goodwill associated therewith.

The Lender agrees, at the Grantor's expense, to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required or desirable to effect the release of the Lender's security interest in the Released Marks.

Grantor, or its designee, may record this Release of Security Interests in Trademarks in the USPTO and in any other offices as may be necessary to carry out the intention of this release, and to the extent applicable, the parties hereto authorize and request that the USPTO record this release of security interest.

This Release of Security Interest in Trademarks shall be governed by, and construed in accordance with, the laws of the State of New York.
