## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS

This Release of Security Interest in Intellectual Property (this "Release"), dated as of April 27, 2016 ("Effective Date"), is made by **SEA ISLAND BANK, A DIVISION OF SYNOVUS BANK**, a Georgia banking corporation, (the "Secured Party") in favor of **STRENGTH OF NATURE, LLC**, a Georgia limited liability company ("Grantor"). All terms used but not otherwise defined herein shall have the meanings ascribed to those terms in the Loan Agreement or the Intellectual Property Agreements, as those terms are defined below);

WHEREAS, the Secured Party and Grantor have entered into to that certain Loan and Security Agreement, dated as of December 4, 2013 (the "Loan Agreement");

WHEREAS, pursuant to the Loan Agreement the Grantor has granted the Secured Party a security interest in certain intellectual property and other assets of Grantor (the "Collateral"), and has entered into that certain Patent Collateral Assignment and Security Agreement dated as of December 3, 2013 and that certain Trademark Collateral Assignment and Security Agreement dated as of December 3, 2013, evidencing such grant in favor of the Secured Party (collectively, the "IP Security Agreements"), whereby Grantor assigned and transferred and granted to the Secured Party a security interest in the Grantor's right, title and interest in all of the Grantor's Patent Collateral and Trademark Collateral, as those terms are further defined in the IP Security Agreements, whether then owned or at any time thereafter acquired by the Grantors (including, without limitation, those Patents listed on Schedule I hereto and those Trademarks listed on Schedule II hereto);

WHEREAS, the Patent Collateral Assignment and Security Agreement was recorded in the United States Patent and Trademark Office against the Patent Collateral of the Grantors on January 10, 2014, at Reel 032082, Frame 0144;

WHEREAS, the Trademark Collateral Assignment and Security Agreement was recorded in the United States Patent and Trademark Office against the Trademark Collateral of the Grantors on January 10, 2014, at Reel 005195, Frame 0149; and

WHEREAS, the Secured Party and Grantor have terminated the Loan Agreement and the IP Security Agreements, as of or prior to the Effective Date, thereby releasing the security interest in the Collateral (including the Patent Collateral and Trademark Collateral) created therein, and assigning any rights Secured Party may have acquired in the Collateral back to Grantors.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Secured Party agrees as follows:

1. The Secured Party hereby terminates, releases, cancels, relinquishes and discharges to the Grantors all liens, collateral pledges, grants, assignments and all security interests that the Secured Party has in, to and under the Collateral, including the Patent Collateral and Trademark Collateral, without warranty or recourse. All rights in, to and under the Collateral secured in the Loan Agreement and IP Security Agreements, including the Patent Collateral and Trademark Collateral, hereby revert to the Grantor, and Grantor has no outstanding obligations to the Secured Party.
2. The Secured Party represents and warrants that it has the full power and authority to execute this Release.
3. The Secured Party hereby agrees, at the expense of Grantor, to take all reasonable actions and to execute all further documents necessary or reasonably requested by Grantor to effectuate, record or evidence the termination, release, cancellation, relinquishment and discharge of any collateral pledges, grants, assignments, liens and/or security interests of the Secured Party in, to and under the assets secured in the Loan Agreement and IP Security Agreements, including the Patent Collateral and Trademark Collateral.
4. The Secured Party authorizes and hereby requests the United States Patent and Trademark Office and/or the applicable foreign authorities to record this Release, and authorizes Grantor to terminate any UCC financing statements and record such terminations with the appropriate authorities.
5. This Release may be executed in any number of separate counterparts, and all of said counterparts taken together shall be deemed to constitute one and the same instrument. Delivery of an executed signature page of this Release by facsimile or other electronic transmission shall be effective as delivery of a manually executed counterpart hereof. This Release sets forth the entire understanding between the parties hereto with respect to the matters described herein and supersedes all prior agreements and understandings, whether oral or written, between the parties hereto with respect to such matters.
6. **THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF GEORGIA APPLICABLE TO CONTRACTS EXECUTED IN AND TO BE PERFORMED IN SUCH STATE, IRRESPECTIVE OF ITS CHOICE OF LAW RULES.**


