RELEASE OF TRADEMARKS

1.

PRCC HOLDINGS, INC., a Delaware corporation ("Holdings"), and PREFERRED COMPOUNDING CORP. (f/k/a Preferred Rubber Compounding Corp., f/k/a Deronde Acquisition Corporation and successor by merger with Associated Rubber Company), a Delaware corporation ("Preferred" and together with Holdings, individually, each a "Grantor"), entered into a certain trademark security interest dated December 8, 2010 and recorded in the United States Patent and Trademark Office on December 9, 2010, at Reel 004428, Frame 0788 (the "Security Agreement"), whereby PNC BANK, NATIONAL ASSOCIATION, a national association organized and existing under the laws of the United States ("Secured Party"), was granted a security interest in certain Collateral (as defined in the Security Agreement), including the trademarks and federal registrations listed on the attached Schedule A (the "Marks").

The Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby at Grantor's expense.
