TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "*Termination and Release*") is granted as of May 9, 2016, by **BANK OF AMERICA, N.A.**, as Agent (the "*Grantee*"), in favor of **AEROPOSTALE, INC.** (f/k/a MSS-Delaware, Inc.), a Delaware corporation ("*Aeropostale*"), **AEROPOSTALE WEST, INC.**, a Delaware corporation ("*West*"), **JIMMY'Z SURF CO., LLC** (f/k/a Jimmy'z Surf Co., Inc.), a Delaware limited liability company ("*Jimmy'z*"), **AERO GC MANAGEMENT, LLC**, a Virginia limited liability company ("*Management*"), **AEROPOSTALE PROCUREMENT COMPANY, INC.**, a Delaware corporation ("*Procurement*", together with Aeropostale, West, Jimmy'z, and Management, individually, a "*Grantor*", and collectively, the "*Grantors*").

WHEREAS, Aeropostale, West, Jimmy'z and Management executed and delivered an Amended and Restated Trademark and Trademark Application Security Agreement dated March 21, 2008 (as amended, modified or supplemented prior to the date hereof, the "*2008 Trademark Agreement*"), granting the Grantee a security interest in and lien on certain trademarks and trademark applications described therein;

WHEREAS, the 2008 Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on May 22, 2008, at Reel 3782, Frame 0011;

WHEREAS, Procurement and West executed and delivered a Grant of Security Interest in United States Trademarks dated September 22, 2011 (as amended, modified or supplemented prior to the date hereof, the "*2011 Trademark Agreement*"), granting the Grantee a security interest in and lien on certain trademarks and trademark applications described therein;

WHEREAS, the 2011 Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on September 22, 2011, at Reel 4627, Frame 0861;

WHEREAS, Procurement and Aeropostale executed and delivered a Grant of Security Interest in United States Trademarks dated February 21, 2014 (as amended, modified or supplemented prior to the date hereof, the "*February 2014 Trademark Agreement*"), granting the Grantee a security interest in and lien on certain trademarks and trademark applications described therein;

WHEREAS, the February 2014 Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on March 17, 2014, at Reel 5238, Frame 0512;

WHEREAS, Procurement executed and delivered a Grant of Security Interest in United States Trademarks dated May 23, 2014 (as amended, modified or supplemented prior to the date hereof, the "*May 2014 Trademark Agreement*"), granting the Grantee a security interest in and lien on certain trademarks and trademark applications described therein;

WHEREAS, the May 2014 Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on May 27, 2014, at Reel 5286, Frame 0816;

WHEREAS, Procurement and West executed and delivered a Grant of Security Interest in United States Trademarks dated August 18, 2015 (as amended, modified or supplemented prior to the date hereof, the “*August 2015 Trademark Agreement*”), granting the Grantee a security interest in and lien on certain trademarks and trademark applications described therein;

WHEREAS, the August 2015 Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on August 19, 2015, at Reel 5602, Frame 0801;

WHEREAS, Procurement executed and delivered a Grant of Security Interest in United States Trademarks dated March 26, 2016 (as amended, modified or supplemented prior to the date hereof, the “*March 2016 Trademark Agreement*”), granting the Grantee a security interest in and lien on certain trademarks and trademark applications described therein;

WHEREAS, the March 2016 Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on March 28, 2016, at Reel 5759, Frame 0005;

WHEREAS, Procurement executed and delivered a Grant of Security Interest in United States Trademarks dated April 1, 2016 (as amended, modified or supplemented prior to the date hereof, the “*April 2016 Trademark Agreement*”, together with 2008 Trademark Agreement, 2011 Trademark Agreement, February 2014 Trademark Agreement, May 2014 Trademark Agreement, August 2015 Trademark Agreement, and March 2016 Trademark Agreement, collectively, the “*Grant*”), granting the Grantee a security interest in and lien on certain trademarks and trademark applications described therein;

WHEREAS, the April 2016 Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on April 4, 2016, at Reel 5764, Frame 0963;

WHEREAS, the Grantors have requested that the Grantee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantors in, to and under all of the trademarks and trademark applications described in the Grants (collectively, the “*Marks*”) as herein provided; and

WHEREAS, the Grantors have requested that the Grantee provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its security interests in and liens on the Marks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby:

1. terminates the Grants and releases, terminates and discharges all liens and security interests in each Grantor's right, title and interest in, to and under the Marks, and all goodwill associated therewith, including those Marks identified in Schedule A hereto;
2. authorizes and requests that this Termination and Release be recorded at the USPTO; and
3. agrees that it shall, and at any Grantor's, or its respective successor's or assign's, reasonable request, execute, acknowledge and deliver to such Grantor all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.

THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS TERMINATION AND RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE COMMONWEALTH OF MASSACHUSETTS.
