## RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of May 25, 2016, by **PACIFIC WESTERN BANK** (as successor in interest by merger to Square 1 Bank) ("Lender") in favor of **BOOKLR ACQUISITION CORP.**, a Delaware corporation ("Company") with its principal place of business located at 229 W 43rd Street, 8th Floor, New York, NY 10036.

### Recitals

WHEREAS Company granted to Lender a security interest in its copyrights, patents and trademarks, including without limitation the trademarks described on Exhibit A attached hereto, (collectively, and together with the goodwill connected with the use thereof and all rights of any kind of Company accruing under such copyrights, patents and trademarks, the "Intellectual Property") under an Intellectual Property Security Agreement dated as of April 28, 2014 (the "Security Agreement"), and recorded with the US Patent and Trademark Office as set forth on Exhibit A.

WHEREAS Company has no outstanding obligations to Lender under the terms of the Security Agreement, Lender agrees to release its security interest in the Intellectual Property.

### Agreement

Now therefore, Lender hereby terminates the Security Agreement and terminates, releases and discharges its security interest that it has pursuant to the Security Agreement in the Intellectual Property and reassigns to Company, without warranty or recourse, all interest of Lender in the Intellectual Property.


Lender agrees to take all further actions, and provide to Company and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as Company and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release of Security Interest. All such further actions, including, without limitation, such further documents and other instruments which are requested by Company to be delivered or filed by Lender on or after the date of this Release of Security Interest shall be prepared at no cost or expense to Lender. Any costs or expenses incurred by Lender with respect to such items (including all reasonable attorneys' fees) shall be reimbursed promptly by Company on demand.

This Release of Security Interest shall be governed by, and construed in accordance with, the laws of the United States and the State of North Carolina, without giving effect to any choice or conflict of law provision or rule.
