**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this "Release") is made as of June 7, 2016, by **Goldman Sachs Bank USA**, in its capacity as administrative agent (in such capacity, the "Administrative Agent"), in favor of **CHG Management, Inc., CHG Healthcare Services, Inc., CHG Medical Staffing, Inc. and CHG Companies, Inc.** (individually, a "Grantor", and, collectively, the "Grantors") pursuant to that certain First Lien Credit Agreement, dated as of November 29, 2012, as amended and restated on November 20, 2013 (and as further amended, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the "First Lien Credit Agreement") among CHG Healthcare Services, Inc., a Delaware corporation (the "Borrower"), CHG Intermediate Corporation, a Delaware corporation ("Holdings"), and the subsidiaries of the Borrower as may have from time to time become a party thereto, the lenders, Goldman Sachs Bank USA, as Administrative Agent, and the other agents, arrangers and bookrunners party thereto. Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Trademark Security Agreements (defined below), or if not defined therein, in the First Lien Security Agreement (defined below).

**WITNESSETH:**

**WHEREAS**, the Grantors are a party to that certain First Lien Security Agreement, dated as of November 19, 2012 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "First Lien Security Agreement") in favor of the Administrative Agent, pursuant to which the Grantors executed and delivered that certain Trademark Security Agreement, dated as of November 19, 2012 (the "First Lien Trademark Security Agreement"), that certain Amended and Restated First Lien Trademark Security Agreement, dated as of July 9, 2013 (as amended, amended and restated, supplemented, or otherwise modified from time to time, the "Amended and Restated First Lien Trademark Security Agreement"), that certain Second Amended and Restated First Lien Trademark Security Agreement, dated as of November 20, 2013 (as amended, amended and restated, supplemented, or otherwise modified from time to time, the "Second Amended and Restated First Lien Trademark Security Agreement") and that certain Third Amended and Restated First Lien Trademark Security Agreement, dated as of May 21, 2015 (as amended, amended and restated, supplemented, or otherwise modified from time to time, the "Third Amended and Restated First Lien Trademark Security Agreement"), and, together with the First Lien Trademark Security Agreement, the Amended and Restated First Lien Trademark Security Agreement and the Second Amended and Restated First Lien Trademark Security Agreement, the "Trademark Security Agreements";

**WHEREAS**, each of the Trademark Security Agreements was assigned to the Administrative Agent in its capacity as successor collateral agent for the Secured Parties on July 9, 2015;

**WHEREAS**, pursuant to the Trademark Security Agreements (as assigned to the Administrative Agent), each of the Grantors pledged and granted to the Administrative Agent for the benefit of the Secured Parties a lien on and security interest in and to all of its right, title and

interest in, to and under all of the following Pledged Collateral of such Grantor: Trademarks of such Grantor listed on Schedule A and Schedule B attached hereto (collectively, the “First Lien Trademark Collateral”);

**WHEREAS**, the First Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 4903, Frame 0474 on November 19, 2012;

**WHEREAS**, the Amended and Restated First Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 5067, Frame 0151 on July 10, 2013;

**WHEREAS**, the Second Amended and Restated First Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 5158, Frame 0778, on November 21, 2013;

**WHEREAS**, the Third Amended and Restated First Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 5522, Frame 0036, on May 21, 2015;

**WHEREAS**, the assignment of the First Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 005573, Frame 0281 on July 9, 2015;

**WHEREAS**, the assignment of the Amended and Restated First Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 005573, Frame 0318, on July 9, 2015;

**WHEREAS**, the assignment of the Second Amended and Restated First Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 005573, Frame 0332, on July 9, 2015;

**WHEREAS**, the assignment of the Third Amended and Restated First Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 005573, Frame 0351, on July 9, 2015

**WHEREAS**, the Administrative Agent acknowledges full performance of the Secured Obligations and accordingly has agreed to release the grant of its lien on and security interest in and to all of the right, title, and interest of the Grantors in the First Lien Trademark Collateral, and to reconvey any and all rights in the First Lien Trademark Collateral to the Grantors.

**NOW THEREFORE**, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby releases, relinquishes and discharges, with respect to each Grantor, all of its lien on and security interest in and to all of such Grantors right, title, and interest in, to

and under the First Lien Trademark Collateral, and re-assigns to such Grantor any and all right, title or interest it may have in such First Lien Trademark Collateral.

The Administrative Agent hereby authorizes the Grantors, or the Grantors' authorized representatives to: (a) record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or Agency and (b) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the Administrative Agent's lien on and security interest in the First Lien Trademark Collateral. The Administrative Agent agrees to execute and deliver to the Grantors all other instruments and other documents as may be necessary or proper to release the lien on and security interest in the First Lien Trademark Collateral which had been granted under the Trademark Security Agreements.

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER (INCLUDING, WITHOUT LIMITATION, ANY CLAIMS SOUNDING IN CONTRACT LAW OR TORT LAW ARISING OUT OF THE SUBJECT MATTER HEREOF AND ANY DETERMINATION WITH RESPECT TO POST-JUDGMENT INTEREST) SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO CONFLICT OF LAWS PRINCIPLES THEREOF THAT WOULD RESULT IN THE APPLICATION OF ANY LAW OTHER THAN THE LAW OF THE STATE OF NEW YORK (OTHER THAN ANY MANDATORY PROVISIONS OF LAW RELATING TO THE LAW GOVERNING PERFECTION AND THE EFFECT OF PERFECTION OF THE SECURITY INTEREST).





