CONFIRMATORY TRADEMARK RIGHTS ASSIGNMENT

THIS CONFIRMATORY TRADEMARK RIGHTS ASSIGNMENT is from NCR Corporation, a Maryland corporation (“Assignor”), to Iconex LLC, a Delaware limited liability company (formerly known as, Receiptco LLC) (“Assignee”).

WHEREAS, pursuant to that certain Amended and Restated Master Acquisition Agreement by and between Assignor and Assignee dated May 27, 2016 (the “Acquisition Agreement”), Assignor sold, assigned and transferred to Assignee certain assets of Assignor, including the Trademark Rights (defined below); and

WHEREAS, in furtherance of Assignor’s obligations under the Acquisition Agreement, Assignor and Assignee desire to confirm of record Assignee’s ownership of all right, title and interest in and to the Trademark Rights.

NOW, THEREFORE, for good and valuable consideration, the sufficiency and receipt of which are hereby acknowledged, the parties hereto agree as follows:

Assignor hereby confirms that it sells, assigns, transfers, and conveys to Assignee, subject to the IP Encumbrances (as defined below), as of the Effective Date (defined below), all right, title, and interest in and to any and all of the following: (a) the registered trademarks, trademark applications and domain names listed in Exhibit A, attached hereto and incorporated herein by reference (the “Trademark Rights”) and all associated goodwill, and (b) all rights to sue for, and obtain remedies in connection with, past, present, and future infringement of the Trademark Rights, including the right to obtain an injunction, royalties, or any other damages, other than Excluded Ancillary IP Rights (defined below).

For the purposes of this Confirmatory Trademark Rights Assignment, “Excluded Ancillary IP Rights” means, with respect to the Trademark Rights, any and all of the rights of Assignor and any of its Affiliates set forth on Exhibit I of the Acquisition Agreement, in any jurisdiction throughout the world to collect and receive any and all damages, costs and other remedies and fees (including royalties and other payments or proceeds) pursuant to or with respect to such Trademark Rights, which were collected or received by, or are due or payable to, Assignor or any such Affiliate as of or prior to the Closing Date. For the purposes of this Confirmatory Trademark Rights Assignment, “IP Encumbrances” means all licenses, releases, covenants not to assert or sue and/or similar rights and/or immunities granted and/or provided under or with respect to any of the Trademark Rights prior to the Effective Date.

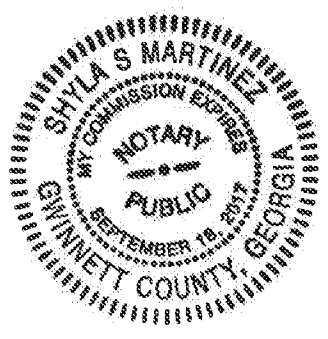

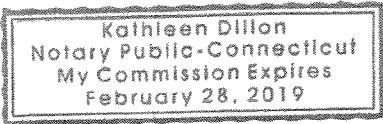
