NOTICE OF RELEASE OF SECURITY INTEREST

This Notice of Release of Security Interest (the "Release") is effective as of April 27, 2016, by **PNC BANK, NATIONAL ASSOCIATION** (together with its successors, "Secured Party").

WHEREAS, reference is made to that certain Notice Of Grant of Security Interest in Trademarks dated as of May 16, 2012 by **FLANDERS CORPORATION**, a North Carolina corporation (the "Grantor"), in favor of Secured Party (the "Security Agreement"); and

Secured Party further agrees to execute any other documents and take any further action which is reasonably necessary in any state, country, or jurisdiction that the Grantor may reasonably require to effect the intent and purpose of this Release, provided that all such documents shall be prepared by Grantor's counsel and the cost and expense of such documents and actions shall be borne solely by the Grantor.
