RELEASE OF SECURITY INTEREST IN TRADEMARKS

2. agrees that any power of attorney or similar rights granted by Grantor to Lender pursuant to or in connection with the Trademark Security Agreement is terminated; and
3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.
