**TERMINATION AND RELEASE OF SECURITY INTEREST
IN PATENTS, TRADEMARKS AND COPYRIGHTS**

THIS TERMINATION AND RELEASE dated as of June 30, 2016, is granted by PNC BANK, NATIONAL ASSOCIATION, as Administrative Agent (the "Agent") for certain lenders, in favor of HIGH RIDGE BRANDS CO., a Delaware corporation ("High Ridge").

WITNESSETH:

WHEREAS, pursuant to (i) the Credit Agreement, dated as of December 9, 2011, made by and among the Agent, High Ridge, the Guarantors party thereto, the Lenders party thereto, and PNC Bank, National Association, as Administrative Agent; and (ii) the Patent, Trademark and Copyright Security Agreement, dated as of December 9, 2011, made by and between the Agent and High Ridge (the "2011 PTC Security Agreement"), security interests (the "2011 Security Interests") were granted by High Ridge in favor of the Agent in certain collateral, including certain Intellectual Property Collateral (as hereinafter defined);

WHEREAS, the 2011 PTC Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on January 23, 2012 at Reel 4702 Frame 0578;

WHEREAS, the 2011 PTC Security Agreement was recorded in the Patent Division of the United States Patent and Trademark Office on January 23, 2012 at Reel 27573 Frame 503;

WHEREAS, pursuant to (i) the Amended and Restated Credit Agreement (as amended, restated, amended and restated, modified or supplemented from time to time), dated as of July 12, 2013, made by and among the Agent, High Ridge, High Ridge Brands Holdings, LLC ("Parent"), the Lenders from time to time party thereto, and PNC Bank, National Association, in its capacity as Administrative Agent; and (ii) the Reaffirmation of Loan Documents, dated as of July 12, 2013, made by and among the Agent, High Ridge and Parent (the "Reaffirmation Agreement"), security interests (together with the 2011 Security Interests, the "Security Interests") granted by High Ridge in favor of the Agent in certain collateral, including certain Intellectual Property Collateral, were reaffirmed (as hereinafter defined);

WHEREAS, the Reaffirmation Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on July 16, 2013 at Reel 5071 Frame 0015, with a Corrective Assignment recorded on November 15, 2013 at Reel 5160 Frame 0136; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. The term "Intellectual Property Collateral," as used herein, shall mean all of High Ridge's right, title and interest of every kind and nature as of the date hereof in all trade names, patent applications, patents, trademark applications, trademarks and copyrights, including without limitation those listed on Schedule A hereto, including all proceeds thereof, the right to sue for past, present and future infringements, all rights corresponding thereto

throughout the world and all reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof, and the good will with the use of, and symbolized by, connected with the business to which any of the Intellectual Property Collateral relates.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Intellectual Property Collateral, and any right, title or interest of the Agent in such Intellectual Property Collateral shall hereby cease and become void.

3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
