RELEASE OF TRADEMARK SECURITY INTEREST

- C. Releasee has requested that Releasor release all of its right, title, and interest in and to the Trademarks, and Releasor has agreed to release all of its right, title, and interest (including all security interests) it may have in and to the Trademarks.

Releasor will execute such other documents and instruments, and take other such actions (at the expense of Releasee) as Releasee may reasonably request to evidence this termination and release and the release of any other security interest Releasor may have in and to the Trademarks.
