Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States and the equivalent office in each state or country in which the Trademarks are registered to record the Assignee as the assignee and owner of the Trademarks and to issue any trademarks which may be granted on any applications included in the Trademarks to the Assignee as assignee of the entire right, title and interest therein and thereto, and Assignor hereby covenants that Assignor has full right to convey Assignor's entire interest herein assigned, and that Assignor has not executed, and will not execute, any agreements in conflict herewith.

Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Trademark Assignment shall be governed by and construed in accordance with the laws of the State of Delaware, without giving effect to the principles of conflicts of laws thereof.

This Trademark Assignment may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Signatures of the parties transmitted by facsimile or other electronic transmission shall be deemed to be their original signatures for all purposes.


