## GRANT OF SECURITY INTEREST IN MATERIAL TRADEMARKS

This Grant of Security Interest in Material Trademarks (the “**Trademark Grant**”), dated July 11, 2016, is between Schenck Process LLC, a Kansas limited liability company (“**Process**”), Stock Equipment Company, Inc., a Delaware corporation (“**Equipment**”, and together with Process, “**Security Providers**”, and each individually a “**Security Provider**”) and Wilmington Trust (London) Limited (the “**Security Agent**”).

WHEREAS the Security Providers own certain rights in Material Trademarks as specifically listed in the attached Schedule A;

WHEREAS the Security Providers and the Security Agent are parties to a security agreement dated as of July 11, 2016 (the “**Security Agreement**”; all capitalized terms not defined herein shall have the meaning assigned to such terms in the Security Agreement) and all ancillary documents entered into in connection with such Security Agreement, all as may be amended from time to time (hereinafter referred to collectively as the “**Loan Documents**”);

WHEREAS pursuant to the terms of the Security Agreement, the Security Providers have granted to the Security Agent a security interest in and to all of the Security Providers’ right, title and interest in and to the Material Trademarks whether presently existing or hereafter arising or acquired, and all products and proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof for the full term of the Material Trademarks, to secure the Secured Liabilities;

NOW, THEREFORE, in consideration of the premises contained herein, the Security Providers agree with the Security Agent as follows:

To secure the complete and timely satisfaction of the Secured Liabilities, the Security Providers hereby grant and convey to the Security Agent a continuing security interest in and lien on all of the Security Providers’ right, title and interest in and to all Material Trademarks listed on Schedule A hereto (as may be amended from time to time) and the proceeds thereof (such as, by way of example, license royalties and proceeds of infringements, all rights corresponding thereto throughout the world) and all reissues, divisions, continuations, reexaminations, substitutions, renewals, extensions and continuations-in-part thereof. The Security Agent is authorized to file this Agreement with the PTO or any other governmental agency it deems necessary or desirable in order to secure and perfect its rights under this Agreement or the Loan Documents.

Notwithstanding anything to the contrary herein, in no event shall Material Trademarks include any application for registration of a Material Trademark filed with the PTO on an intent-to-use basis to the extent an assignment of such applied for registration would void or invalidate such application, until such time (if any) that a verified statement of use (or the equivalent) for such Material Trademark is filed with and accepted by the PTO at which time such Material Trademark shall automatically become part of the Collateral and subject to the security interest granted hereunder.
