RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of July 25, 2016 by FIDUS MEZZANINE CAPITAL, L.P. (the “Collateral Agent”) in favor of AMERICAN TRUCK PROTECTION LLC, a New Jersey limited liability company (the “Grantor”). Capitalized terms used but not otherwise defined herein have the meanings set forth in the Security Agreement or the Trademark Security Agreement (each, as defined below).

WHEREAS, the Grantors and Collateral Agent entered into that certain Pledge and Security Agreement, dated as of August 10, 2012 (as amended, modified, restated or supplemented from time to time, the “Security Agreement”); and

WHEREAS pursuant to the Security Agreement, that certain Grant of Security Interest in Trademarks, dated August 10, 2012 (the “Trademark Security Agreement”) was (a) entered into by the Grantors and the Collateral Agent to record the security interest with respect to the Trademarks (as defined in the Trademark Security Agreement) set forth on Schedule A hereto, and (b) recorded with the United States Patent and Trademark Office on August 13, 2012, at Reel Number 4841, Frame Number 0028; and

WHEREAS, the Grantors and the Collateral Agent have agreed to a specific release of the security interest granted and recorded against the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby (i) terminates the Trademark Security Agreement and releases and re-assigns to the Grantors any and all liens and security interests, and any other right, title and interest it may have in, to and under the Trademarks set forth on Schedule A hereto; (ii) agrees that it shall execute all other documents and do all other acts reasonably requested by Grantor to relinquish and effect the release of such rights to the Grantors, all at the expense of Grantors; and (iii) authorizes and requests that the United States Patent and Trademark Office to note and record the release hereby given and any other filings necessary to evidence the release and termination of the Collateral Agent’s rights under the Trademark Security Agreement with respect to the Trademarks.
