## **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “**Release**”) is made as of the 8th day of August, 2016, by SILICON VALLEY BANK, a California corporation (the “**Assignor**”), for the benefit of SPIGIT, INC., a Delaware corporation (“**Assignee**”).

WHEREAS, in connection with that certain Loan and Security Agreement dated September 10, 2013 (as the same may from time to time be amended, modified, supplemented or restated, the “**Loan Agreement**”), Assignee and Assignor entered into that certain Intellectual Property Security Agreement dated September 10, 2013 (the “**IP Agreement**”; together with the Loan Agreement, collectively, the “**Agreements**”) for the purpose of securing certain obligations of Assignee to Assignor;

WHEREAS, pursuant to the Agreements, Assignee granted the Assignor, for the benefit of the Assignor, a security interest in all of the Copyrights, Trademarks, Patents, and Mask Works (as defined in the Agreements) (collectively hereinafter the “**Intellectual Property**”), including the Intellectual Property identified on Exhibits A and B attached hereto (the “**Released Intellectual Property**”), and pledged and mortgaged (but did not transfer title to) the Intellectual Property to Assignor; and

WHEREAS, the IP Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office, on September 11, 2013 at Reel/Frame 5109/0229;

WHEREAS, the IP Agreement was recorded with the Patent Division of the United States Patent and Trademark Office, on September 11, 2013 at Reel/Frame 031207/0238; and

WHEREAS, the Assignor has agreed to release its security interest in the Released Intellectual Property.

NOW, THEREFORE, for valuable consideration and pursuant to the terms and conditions set forth in the Agreements:


