**Pursuant to the provisions of § 55-11-07 of the  
North Carolina Business Corporation Act**

**Dated as of September 24th, 2012**

GFD Services, Inc., a Delaware corporation (the "Company"), in connection with the merger of GFD Fabrics, Inc., a North Carolina corporation ("Fabrics"), with and into the Company, hereby certifies that:

FIRST: The name and state of incorporation of each of the constituent corporations of the merger are as follows:

GFD Services, Inc.	Delaware

SECOND: The Company is the surviving corporation of the merger, and the name of the surviving corporation shall be "GFD Services, Inc." (the "Surviving Corporation").

THIRD: The certificate of incorporation of the Surviving Corporation shall continue in full force and effect as its certificate of incorporation following the merger.


FOURTH: The principal address of the Surviving Corporation shall be 21557 Telegraph Road, Southfield, Michigan 48033.

FIFTH: The Agreement and Plan of Merger, dated as of September 24, 2012 (the "Merger Agreement"), between the Company and Fabrics has been duly approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with §§ 55-11-01 and 55-11-07 of the North Carolina Business Corporation Act and under applicable Delaware law.

SIXTH: The merger shall be effective as of 11:58 p.m. Eastern Standard Time on September 29, 2012.
