RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST ("**Release**") dated June 30, 2016 and granted by Wells Fargo Capital Finance, LLC (the "**Lender**"), successor by merger of Wells Fargo Capital Finance, Inc., formerly known as Wells Fargo Foothill, Inc., formerly known as Foothill Capital Corporation ("**Foothill**") in favor of Jayco, Inc. ("**Jayco**"), as successor in interest to certain intellectual property rights once owned by Starcraft Automotive Group, Inc. and Starcraft Corporation (collectively, "**Starcraft**") and its successors, assigns and legal representatives.

WHEREAS, Starcraft Automotive Group, Inc. granted a security interest to Foothill in certain trademarks listed on Schedule "A" attached hereto, and associated goodwill, pursuant to that certain Trademark Mortgage dated October 30, 1998 and recorded with the U.S. Patent and Trademark Office on December 1, 1998 at Reel/Frame 1822/0049-0055;

WHEREAS, Starcraft Corporation granted a security interest to Foothill in certain trademarks listed on Schedule "B" attached hereto, and associated goodwill, pursuant to that certain Trademark Mortgage dated October 30, 1998 and recorded with the U.S. Patent and Trademark Office on December 4, 1998 at Reel/Frame 1822/0008-0013;

WHEREAS, the trademarks identified in Schedules A and B are referred to herein as the "**Collateral**";

WHEREAS, Jayco is the successor in interest to Starcraft as to certain trademarks identified on Schedules A and B; and

WHEREAS, Jayco has requested that the Lender release its lien on and continuing security interest in, all right, title and interest of the Lender in and to the Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby terminates the above-referenced Trademark Mortgages and terminates, releases and discharges its lien and any and all security interests that it has in the Collateral, and reassigns to Jayco any and all right, title and interest that it may have, in, to and under the Collateral to the extent it has been acquired by Jayco, including:

(i) the Collateral listed on Schedules A and B hereto, and all of the goodwill of the business connected with the use of, and symbolized by, such Collateral; and


(ii) All proceeds of the foregoing, including without limitation any claims against third parties for damages by reason of past, present or future infringement of any of the Collateral listed on Schedules A and B hereto or by any reason of injury to the goodwill associated with any of the Collateral listed on Schedules A and B hereto or by reason of injury to the goodwill associated with any Collateral, in each case together with the right to sue for and collect said damages.

The Lender agrees to provide to Jayco any information and additional authorization and documentation necessary to effect the release of the Lender's security interest in the Collateral, without recourse, representation or warranty, and at the Jayco's sole cost and expense).
