RELEASE OF TRADEMARK SECURITY INTEREST, dated as of August 29, 2016 (this "Release") and with effect as of December 22, 2004, by Credit Suisse First Boston, in its capacity as Administrative Agent and Collateral Agent (as defined below), in favor of the Company (as defined below). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Trademark Security Agreement, as applicable, referred to below.

Reference is made to (i) the Credit Agreement dated as of March 30, 2004 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Vertafore, Inc., a Delaware corporation (the "Company"), the Lenders party thereto, Credit Suisse First Boston, as administrative agent and as collateral agent (in such capacities, the "Administrative Agent" and the "Collateral Agent" respectively) and the other agents party thereto and (ii) the Trademark Security Agreement dated as of March 30, 2004 (as supplemented or otherwise modified from time to time, the "Trademark Security Agreement") among the Company, the Debtors party thereto and the Collateral Agent.

WHEREAS, pursuant to the Credit Agreement and the Trademark Security Agreement, the Company granted a security interest to the Collateral Agent, for the benefit of the Secured Parties, in the Collateral (as defined in the Trademark Security Agreement), including in, among other things, the trademarks of the Company set forth on Schedule I hereto (the "Trademarks"), which security interest was recorded with the United States Patent & Trademark Office on October 22, 2004 at Reel/Frame 003069/0092.

WHEREAS, in connection with the termination of the Credit Agreement and the Trademark Security Agreement, which occurred on December 22, 2004, the Company has informed the Collateral Agent of its desire to obtain the release of all right, title and interest of the Collateral Agent, the Secured Parties and each other grantee or beneficiary in and to the Trademarks granted under the Trademark Security Agreement.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby release, cancel, relinquish, terminate and discharge any and all security interests it has against the Collateral and reassigns all right, title and interest it may have in the Collateral to the Company. The Collateral Agent authorizes the Company to file this Release with the United States Patent and Trademark Office to evidence the release and termination of the Collateral Agent's security interests in the Trademarks made hereunder. The Collateral Agent shall take all further actions and provide to the Company, assigns or other legal representatives all such cooperation and assistance, as reasonably requested by the Company and at the sole cost and expense of the Company, to more fully and effectively effectuate the purposes of this Release. The execution and/or delivery of this Release by the Collateral Agent shall be without recourse to or warranty by the Collateral Agent or any Secured Party.

THIS RELEASE SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE PARTIES HERETO AND THEIR RESPECTIVE SUCCESSORS AND ASSIGNS.


