## TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment") is made and entered into this 22nd day of October, 2014 by and among bubba brands, inc., a Georgia corporation ("Seller"), In Zone Holdings, Inc., a Georgia corporation ("In Zone," together with Seller, "Assignors"), and Rubbermaid Incorporated, an Ohio corporation ("Assignee"), pursuant to the Asset Purchase Agreement, dated as of October 1, 2014, by and among Assignors, Assignee and, solely for the purposes of Sections 7.8(b) and 7.9 and Articles 1 and 11 thereof, Jim Scott (the "Purchase Agreement").

WHEREAS, in accordance with and subject to the Purchase Agreement, Assignors desire to assign to Assignee all of Assignors' right, title and interest in and to the trademarks set forth on Schedule A and the goodwill associated therewith (collectively, the "Trademarks").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors and Assignee, each intending to be legally bound, hereby agree as follows:

1. Assignors do hereby sell, assign, transfer and set over to Assignee, and Assignee hereby accepts the transfer and assignment of, Assignors' entire right, title and interest in and to the Trademarks, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignors if this Assignment had not been made, together with all income, royalties or payments in respect of the Trademarks due or payable as of the date hereof or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Trademarks, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

2. Assignee shall request the Commissioner of Patents and Trademarks of the United States or the analogous individual or agency responsible for trademarks, service marks, trade/assumed names in other countries referenced in Schedule A, to record Assignee as owner of the Trademarks, including any variations thereof, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives.

3. Pursuant to Section 7.10 of the Purchase Agreement, Assignors shall provide Assignee, its successors, assigns or other legal representatives, with reasonable cooperation and assistance at Assignee's request (including the execution and delivery of any and all documentation as may be reasonably required) in the recordation of this Assignment.

4. This Assignment is being executed solely to give effect to the transactions contemplated by the Purchase Agreement. Nothing in this Assignment, express or implied, is intended to or shall be construed to modify, expand or limit in any way the terms of the Purchase Agreement. To the extent that any provision of this Assignment conflicts or is

inconsistent with the terms of the Purchase Agreement, the Purchase Agreement shall govern.

5. This Assignment may be executed in two or more counterparts, each of which shall be deemed an original, but all of which when taken together shall constitute one and the same instrument. Facsimiles or other electronic copies of signatures shall be deemed to be originals.


