SERVICE MARK ASSIGNMENT AGREEMENT

This Service Mark Assignment Agreement (“Agreement”) is entered into this 29th day of February, 2016 (“Effective Date”) by and between Allied Reliability Inc., an Ohio corporation with offices at 4200 Faber Place Drive, North Charleston, South Carolina 29405 (“Assignor”), and Eruditio, LLC, a South Carolina limited liability company whose address is 40 Patriots Point Road, Mount Pleasant, South Carolina 29464 (“Assignee”).

WHEREAS, Assignor is the owner of the service marks and corresponding registrations in the United States listed in Exhibit A hereto (collectively, the “Marks”);

WHEREAS, Assignor and Assignee are parties to a certain Business Alliance and Transition Agreement dated March 17, 2014, as updated March 1, 2015 (the “Alliance Agreement”) that includes terms relating to the licensing and transfer of the Marks between the parties;

WHEREAS, U.S. Bank National Association has provided an executed release (the “Release”) of its lien and security interest in the Marks (the “Lien”) in favor of Assignor, and a copy of such Release is attached as Exhibit B hereto; and

WHEREAS, Assignee is desirous of acquiring Assignor's rights in the Marks;

NOW, THEREFORE, in consideration of payment by Assignee of One Hundred Dollars (\$100.00) and the mutual promises herein made, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Assignor hereby conveys and assigns to Assignee all of Assignor's rights, title and interest in and to the Marks (including their corresponding registrations), together with the goodwill of the business connected with the use of and symbolized by said Marks, and together with any and all interests, claims and rights for damages and profits by reason of any past infringement or unauthorized use of the Marks and the right to sue therefor.

2. Assignor shall record the Release of the Lien with the U.S. Patent and Trademark Office (“USPTO”) in association with each of the Marks within one (1) day after the Effective Date.

3. Assignor represents and warrants that:

- a. Assignor owns the entire right, title and interest in and to the Marks as registered with the USPTO;
- b. Other than to Assignee, Assignor is, to its knowledge, not currently licensing the Marks to any other person or entity;
- c. Other than with respect to recording the release of the Lien, there are no liens, claims, security interests, or other encumbrances against the Marks;

- d. Assignor has all authority necessary to enter into this Agreement and the execution and delivery of this Agreement has been duly and validly authorized; and
- e. execution of this Agreement and performance of Assignor's obligations under this Agreement shall not violate or conflict with any other agreement to which Assignor is a party or any provision of Assignor's by-laws or other corporate documents.

4. Each party hereto agrees to perform all reasonable and proper additional acts and to execute any additional documents reasonably requested by the other party (and at the expense of such requesting party) which are necessary in order for such requesting party to satisfy its obligations hereunder or to obtain the benefits of the transactions contemplated hereby.

5. After the Effective Date, Assignor agrees to make no further use of the Marks or any mark featuring the letters "IBL" as a separate word (e.g., Assignor could use the words accessible, combustible, possible, reproducible, reversible and visible), except as may be expressly authorized by Assignee in writing, and Assignor agrees not to initiate any proceeding to challenge Assignee's use or ownership of the Marks or the validity of the Marks.

6. Assignor and Assignee agree that the terms of this Agreement shall take precedence over any contrary terms of the Alliance Agreement (including without limitation Sections 5, 12, 13.d, and 29.j of the Alliance Agreement), and that termination or breach of the Alliance Agreement by any party shall not change the assignment or other terms of this Agreement.

7. This Agreement shall be binding and inure to the benefit of the parties to this Agreement and their successors and assigns, if any.

8. Miscellaneous.

a. Exhibits A and B are hereby incorporated herein by reference. No modifications of or additions to this Agreement shall have effect unless in writing and properly executed by both parties, making specific reference to this Agreement by date, parties, and subject matter.

b. This Agreement and the rights and obligations of the parties hereunder shall be governed by and construed in accordance with the laws of the State of South Carolina, without regard to its conflict of laws principles, and shall be enforceable against the parties in the courts of the State of South Carolina. For such purpose, each party hereby irrevocably submits to the jurisdiction of such courts, and agrees that all claims in respect of this Agreement may be heard and determined in any of such courts.

c. This Agreement may be signed in counterparts, in which case attachment of all of the signature pages to this Agreement shall constitute a fully executed agreement.

d. Any provision of this Agreement that is invalid, illegal or unenforceable in any jurisdiction shall, as to that jurisdiction, be ineffective to the extent of such invalidity, illegality or unenforceability, without affecting in any way the remaining provisions of this Agreement in such jurisdiction or rendering that or any other provision of this Agreement invalid, illegal or unenforceable in any other jurisdiction.







PARTIAL RELEASE OF SECURITY AGREEMENT

THIS PARTIAL RELEASE OF SECURITY AGREEMENT (this "Release") is made and entered into this 10th day of February, 2016, by U.S. BANK NATIONAL ASSOCIATION, a national banking association ("Administrative Agent"), in favor of ALLIED RELIABILITY INC., an Ohio corporation ("Debtor").
