## RELEASE OF TRADEMARK SECURITY INTERESTS

THIS RELEASE OF TRADEMARK SECURITY INTERESTS is granted as of October 30, 2015, in favor of Cutex Nails, LLC, a Missouri limited liability company ("Debtor") by Enterprise Bank & Trust ("Secured Party").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of August 31, 2010, by and between Debtor and Secured Party (the "Trademark Security Agreement"), Debtor granted a security interest to Secured Party in and on all of its right, title and interest in and to certain Collateral as such term is defined in the Trademark Security Agreement; and

WHEREAS, such Trademark Security Agreement was recorded within the records of the United States Patent and Trademark Office on September 27, 2010, at reel 004284, frame 0834; and

WHEREAS, Debtor has agreed to have Secured Party formally release its security interest with respect only to the Collateral; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

A. Secured Party does hereby release and forever discharge and reconvey to Debtor all of Secured Party's security interest in, to and under the Collateral, including without limitation those trademark applications and registrations identified on Schedule A, attached hereto, together with the goodwill associated therewith (collectively, the "Released Secured Property");

B. Secured Party acknowledges and affirms that all of the rights and remedies of Secured Party with respect to the security interest concerning the Released Secured Property have been and are hereby extinguished;

C. At Debtor's expense, Secured Party further agrees to perform all additional acts reasonably necessary (including executing additional documents that are reasonably requested) to confirm that Secured Party has no interests of any type in, to, or under the Released Secured Property; and

D. Secured Party represents and warrants that it has not transferred, pledged, or otherwise encumbered any of its rights in the Trademark Security Agreement and that it has all requisite power and authority to execute this RELEASE OF TRADEMARK SECURITY INTERESTS.

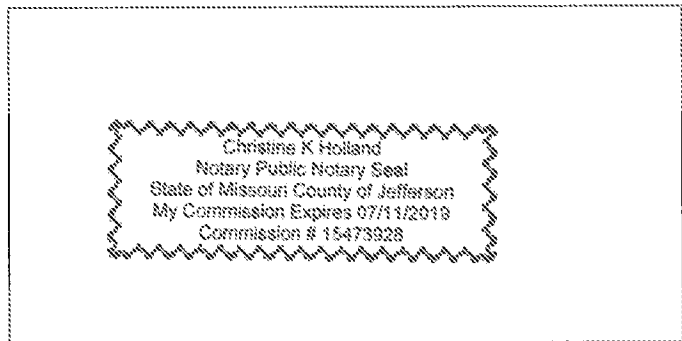
