## ASSIGNMENT

**WHEREAS**, pursuant to an Asset Purchase Agreement, dated June 8, 2015 and amended on October 30, 2015 between Seller and Purchaser (the "APA"), BASF Corporation, a Delaware corporation, having a principal place of business at 100 Park Avenue, Florham Park, NJ 07932, BASF SE, a European corporation, having a principal place of business at 100 Park Avenue, Florham Park, NJ 07932 (BASF Corporation and BASF SE are collectively referred to herein as, "Seller" in the APA) and IMERYS Kaolin, Inc., a Delaware corporation have agreed to transfer the Proprietary Rights (as defined in the APA) of Seller to IMERYS Kaolin, Inc. ("Purchaser" in the APA);

**WHEREAS**, to the extent any of the Proprietary Rights, as defined in the APA and as further provided in Exhibit A, are held by BASF Catalysts LLC ("BASF Catalysts"), a Delaware Corporation, having a principal place of business at 100 Park Avenue, Florham Park, NJ 07932, BASF Catalysts desires to sell, assign and transfer to BASF Corporation such Proprietary Rights;

**WHEREAS**, to the extent any of the Proprietary Rights, as defined in the APA and as further provided in Exhibit A, are held by held by BASF Catalysts LLC F/K/A Engelhard Corporation, ("Engelhard"), having a principal place of business at 100 Park Avenue, Florham Park, NJ 07932, Engelhard desires to sell, assign and transfer to BASF Corporation such Proprietary Rights;

**WHEREAS**, this assignment is made contemporaneously with assignment from Seller to Purchaser;

**WHEREAS**, BASF Corporation is desirous of acquiring the entire interest in such Intellectual Property provided in Exhibit A; and

**NOW, THEREFORE**, for good and valuable consideration, the sufficiency and receipt of which are acknowledged, BASF Catalysts and/or Engelhard, intending to be legally bound does hereby sell, assign, transfer and deliver unto BASF Corporation, its successors, legal representative and assigns, the entire right, title, and interest throughout the world in, to and under the trademarks, goodwill of trademarks, patent applications and patents listed in Exhibit A ("Intellectual Property") (including all non-provisionals, divisionals, continuations, continuations in part, reexaminations, reissues and all other applications for any patent that has been or shall be tiled, issued or granted in the United States and all foreign countries on such inventions, including but not limited to utility models, designs, design patents and envelope soleau and like rights of exclusion) and the right to claim priority based on the filing date of any Intellectual Property under the International Convention for the Protection of Industrial Property, the Patent Cooperation Treaty, the European Patent Convention, and all other treaties of like purposes; and all other rights associated with the Intellectual Property, including without limitation, the

right to sue for any past infringement of the Intellectual Property (collectively, the "IP Rights"). BASF Catalysts and/or Engelhard authorizes the BASF Corporation to apply in all countries in our name or in its own name for patents, utility models, design registrations and like rights of exclusion and for inventors' certificates for said inventions). BASF Catalysts and/or Engelhard shall, from time to time, execute and deliver to BASF Corporation, without further compensation, such additional instruments, documents, conveyances or assurances and take such other action as shall be necessary or otherwise reasonably requested by BASF Corporation to confirm and assure the rights and obligations provided for in this Agreement and the APA and render effective the consummation of the transactions contemplated hereby and thereby including, but not limited to the execution of all non-provisionals, divisionals, continuations, continuations-in-part, reexaminations, reissues, and all other patent applications on the invention; execute all lawful oaths, declarations, assignments, powers of attorney and other papers; communicate to BASF Corporation all facts known to the BASF Catalysts and/or Engelhard relating to the invention and the history hereof; and generally do everything possible which BASF Corporation shall consider necessary for vesting title to the IP Rights in BASF Corporation, and for securing, maintaining and enforcing proper protection for the IP Rights.
