This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination and Release") is executed as of October 18, 2016, by Bank of America, N.A. The Secured Party does hereby certify that the security interests it holds in the right, title and interest to all of the Trademarks, pursuant to that certain Trademark Security Agreement dated as of December 24, 2014 which was recorded with the United States Patent and Trademark Office on January 9, 2015 at Reel 5437, Frame 886 (the "Trademark Security Agreement"), by and among the Debtor, the other grantors party thereto and Secured Party, are released and terminated and all interests in the Trademarks previously assigned to the Secured Party under the Trademark Security Agreement are hereby reassigned to the Debtor, without recourse or representation or warranty, express or implied, of any kind.

This Termination and Release shall be governed by the laws of the State of New York and shall relate solely to the Trademark Security Agreement.
