**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of October 28, 2016 (this "Release"), is made by Credit Suisse AG, Cayman Islands Branch, as Collateral Agent ("Agent"), in favor of Genoa, a QoL Healthcare Company, LLC ("Grantor") as follows:

WHEREAS, pursuant to the First Lien Intellectual Property Security Agreement, dated as of April 30, 2015 (the "Security Agreement"), and recorded with the U.S. Patent and Trademark Office on May 4, 2015 at Reel/Frame No. 5509/0523, Genoa Healthcare, LLC granted the Agent a security interest in certain collateral pledged by the Grantor described therein, including, without limitation, the United States trademark set forth on Schedule A attached hereto (collectively, the "Trademark Collateral");


