SUPPLEMENT TO GRANT OF SECURITY INTEREST IN TRADEMARKS



The Grantor hereby confirms the grant to the Grantee, as set forth in the Trademark Security Agreement (as supplemented hereby) of, and does hereby grant to the Grantee a continuing security interest in and lien upon all of the Grantor’s right, title and interest in and to (i) the Marks (including those set forth in the attached Supplement to Schedule A to Trademark Security Agreement), together with (ii) all Proceeds (as such term is defined in the Credit Agreement) of the Marks, (iii) all of the goodwill of the businesses with which the Marks are associated, and (iv) all causes of action, past, present and future, for infringement, misappropriation, or dilution of any of the Marks or unfair competition regarding the same.
