## INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this “IP Assignment”), effective as of October 11, 2016 (the “Effective Date”), is made and entered into by and among China Mist Brands, Inc., an Arizona corporation, with its principal office at 7435 E. Terra Buena Lane, Scottsdale, Arizona 85260 (“Assignor”), and China Mist Brands, Inc., a Delaware corporation formerly known as Tea Leaf Acquisition Corp., with its principal office at 13601 North Freeway, Suite 200, Fort Worth, Texas 76177 (“Assignee”). Capitalized terms used herein and not otherwise defined have the meanings given to such terms in the Purchase Agreement (as defined below).

### RECITALS

A. Assignor owns the trademark registrations and applications for registration identified more fully in the attached Schedule A (collectively, the “Assigned Trademarks”).

B. Assignor owns the copyright registrations and applications for registration identified more fully in the attached Schedule B (collectively, the “Assigned Copyrights”).

C. Assignor owns the defensive domain registrations identified more fully in the attached Schedule C (collectively, the “Assigned Domains” and together with the Assigned Trademarks and the Assigned Copyrights, the “Intellectual Property”).

D. Assignor, Assignee, certain stockholders of Assignor, for certain limited purposes, Daniel W. Schweiker and John S. Martinson, and Daniel W. Schweiker, in his capacity as the Sellers’ Representative, have entered into that certain Purchase Agreement, dated as of September 9, 2016 (the “Purchase Agreement”), pursuant to which Assignor has agreed to transfer to Assignee, and Assignee has agreed to accept from Assignor, certain assets, properties and business, including without limitation, the Intellectual Property which is used by Assignor or which pertain to the transferred assets, properties and business of Assignor.

NOW, THEREFORE, in consideration of the mutual promises contained in the Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Assignor, and subject to the terms and conditions of the Purchase Agreement:

1. Assignment of Intellectual Property. Assignor hereby assigns to Assignee all of Assignor’s right, title and interest in and to the Intellectual Property, subject to existing licenses, the goodwill of the Business symbolized thereby, and all benefits, privileges, causes of action, and remedies relating thereto throughout the world, including, without limitation, exclusive right to: (a) apply for and maintain all registrations, renewals and/or extensions thereof, (b) bring actions and recover damages for past, present and future infringement or other violation thereof, and (c) grant licenses or other interests therein.

2. Recordation of Assignment. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable governmental entity or registrar (including any applicable foreign or international office or registrar), to record Assignee as owner of the Intellectual Property, and to issue any and all Intellectual Property to Assignee, as assignee of Assignor’s entire right, title and interest in, to, and under the same. Assignee shall have the right to record this IP Assignment with all applicable government authorities and registrars so as to perfect its ownership of the Intellectual Property.

3. Further Assurances. Assignor shall provide Assignee, its successors, assigns and other legal representatives, reasonable cooperation and assistance at Assignee’s request and expense (including the execution and delivery of any and all affidavits, declarations, oaths, exhibits, assignments, powers of

attorney or other documentation as may be reasonably required) as are requested by Assignee to register or perfect the rights assigned herein, including the preparation, execution, and delivery of all documentation which may be reasonably necessary to further document and record the assignment of the Intellectual Property made herein. If Assignee is unable for any reason, after reasonable effort, to secure the Assignor's signature on any document needed in connection with the actions specified above, Assignor hereby irrevocably designates and appoints Assignee and its duly authorized officers and agents as its agent and attorney in fact, which appointment is coupled with an interest, to act for and in its behalf to execute, verify and file any such documents and to do all other lawfully permitted acts to further the purposes of this Section 3 with the same legal force and effect as if executed by Assignor.

4. Binding on Successors; No Third Party Beneficiaries. This IP Assignment and all of the provisions hereof shall be binding upon and inure to the benefit of the Assignee and its successors and permitted assigns. This IP Assignment is not intended to confer any rights or remedies to any Person other than the Assignee and its successors and permitted assigns.

5. Governing Law. This IP Assignment shall be governed by and construed in accordance with the Laws of the State of Texas (regardless of the Laws that might otherwise govern under applicable principles of conflicts of laws thereof) as to all matters, including matters of validity, construction, effect, performance and remedies.

6. Dispute Resolution; Arbitration. Except for any rights that any Party may have to apply to a court of competent jurisdiction for specific performance or injunctive relief, all Legal Disputes shall be submitted solely and exclusively to final and binding arbitration before a single, neutral arbitrator before the American Arbitration Association ("AAA"), in accordance with the AAA's prevailing National Rules for the Resolution of Commercial Disputes. Such arbitration shall proceed in Dallas, Texas, and the demand for arbitration shall be filed with the AAA only after the initiating Party provides the other Party with at least thirty (30) days' advance notice of the contemplated demand. Judgment upon the award rendered by the arbitrator may be entered in any court of competent jurisdiction. The initiating Party shall advance the arbitration filing fee, and all other AAA administrative fees shall be shared equally by the Parties to such a dispute, subject to apportionment by the arbitrator in the award.

7. Ancillary Proceedings. Any Party may bring a suit, action or special proceeding for the purpose of compelling a party to arbitrate, seeking temporary or preliminary injunctive relief in aid of and pending arbitration hereunder, and/or enforcing an arbitration award. EACH PARTY HEREBY IRREVOCABLY SUBMITS TO THE NON-EXCLUSIVE JURISDICTION OF COURTS LOCATED IN DALLAS COUNTY IN THE STATE OF TEXAS FOR THE PURPOSE OF ANY JUDICIAL PROCEEDING BROUGHT IN ACCORDANCE WITH THE PROVISIONS OF THIS SECTION 7. The Parties acknowledge that the forum(s) designated by this Section 7 have a reasonable relation to this Agreement, and to the Parties' relationship with one another. The Parties hereby waive, to the fullest extent permitted by applicable Law, any objection which they now or hereafter may have to personal jurisdiction or to the laying of venue of any such ancillary suit, action or proceeding brought in any court referred to in this Section 7 and such Parties agree not to plead or claim the same.

8. Waiver of Jury Trial. EACH PARTY ACKNOWLEDGES AND AGREES THAT ANY CONTROVERSY WHICH MAY ARISE UNDER THIS IP ASSIGNMENT IS LIKELY TO INVOLVE COMPLICATED AND DIFFICULT ISSUES AND, THEREFORE, EACH SUCH PARTY IRREVOCABLY AND UNCONDITIONALLY WAIVES ANY RIGHT IT MAY HAVE TO A TRIAL BY JURY IN RESPECT OF ANY LEGAL DISPUTE ARISING OUT OF OR RELATING TO THIS IP ASSIGNMENT OR THE TRANSACTIONS CONTEMPLATED HEREBY. EACH PARTY CERTIFIES AND ACKNOWLEDGES THAT (A) NO REPRESENTATIVE OF ANY OTHER PARTY HAS REPRESENTED, EXPRESSLY OR OTHERWISE, THAT SUCH OTHER PARTY WOULD NOT SEEK

TO ENFORCE THE FOREGOING WAIVER IN THE EVENT OF A LEGAL DISPUTE, (B) SUCH PARTY HAS CONSIDERED THE IMPLICATIONS OF THIS WAIVER, (C) SUCH PARTY MAKES THIS WAIVER VOLUNTARILY, AND (D) SUCH PARTY HAS BEEN INDUCED TO ENTER INTO THIS IP ASSIGNMENT BY, AMONG OTHER THINGS, THE MUTUAL WAIVERS AND CERTIFICATIONS IN THIS SECTION 8.

9. Counterparts. This IP Assignment may be executed in counterparts, each of which shall be deemed to be an original, but all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this IP Assignment by facsimile or email transmission shall be as effective as delivery of a manually executed counterpart of this IP Assignment.



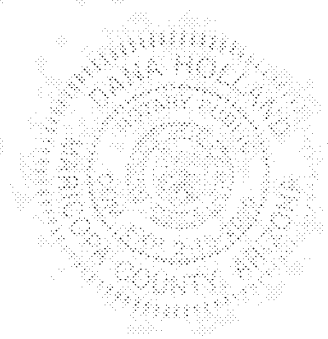


