**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of November 9, 2016, and made by Wilmington Trust, National Association, as collateral agent for the Secured Parties pursuant to the Security Agreement referred to below (in such capacity, the "Collateral Agent"), to inVentiv Health, Inc., a Delaware corporation, Addison Whitney LLC, a North Carolina limited liability company, Adheris, Inc. (n/k/a Adheris, LLC), a Delaware limited liability company, Biosector 2 LLC, a New York limited liability company, Blue Diesel, LLC, an Ohio limited liability company, Cadent Medical Communications, LLC, an Ohio limited liability company, Campbell Alliance Group, Inc. (n/k/a inVentiv Health Consulting, Inc.), a North Carolina corporation, Chandler Chicco Agency, L.L.C., a New York limited liability company, Chandler Chicco Companies LLC (n/k/a inVentiv Health Public Relations, LLC), a Delaware limited liability company, Encuity Research, LLC (n/k/a inVentiv Health Research & Insights, LLC), a Delaware limited liability company, Gerbig Snell/Weisheimer Advertising, LLC, an Ohio limited liability company, Ignite Health LLC (n/k/a Inventiv Health Public Relations, LLC), a Delaware limited liability company, inVentiv Communications, Inc., an Ohio corporation, inVentiv Health Clinical, Inc., a Delaware corporation, inVentiv Health Clinical, LLC, a Delaware limited liability company, inVentiv Health Clinical SRS, LLC, a Florida limited liability company, inVentiv Medical Management LLC (n/k/a Adheris, LLC), a Georgia limited liability company, Medconference LLC (n/k/a Chamberlain Communications Group LLC), a Delaware limited liability company, Palio + Ignite, LLC, an Ohio limited liability company, ParagonRX International LLC, a Delaware limited liability company, Patient Marketing Group LLC, a New Jersey limited liability company, Pharmaceutical Institute, Inc. (n/k/a Pharmaceutical Institute, LLC), a North Carolina corporation, Raven Holdco LLC (n/k/a inVentiv Health Clinical, Inc.), a Delaware limited liability company and The Selva Group, LLC, an Ohio limited liability company (the "Grantors" and each, a "Grantor").

WHEREAS, pursuant to (i) that certain Trademark Security Agreement, dated as of August 12, 2014, by the Grantors in favor of the Collateral Agent (the "Trademark Security Agreement") and (ii) that certain Security Agreement, dated as of August 12, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), by and among, *inter alios*, each Grantor and the Collateral Agent, a lien on and security interest in all right, title and interest in and to any and all of each Grantor's rights (the "Interests") in certain collateral then owned or thereafter acquired by such Grantor was granted by each Grantor to the Collateral Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Interests were recorded in the Trademark Assignment Division of the United States Patent and Trademark Office on August 26, 2014, at Reel 5351 and Frame 0803; and

WHEREAS, the Collateral Agent acknowledges full performance by each Grantor of the Obligations and accordingly the Collateral Agent now desires to terminate and release the Interests and to reconvey any and all rights in the Trademark Collateral to the Grantors.

NOW, THEREFORE, for good and valuable consideration, the Collateral Agent hereby, on behalf of itself and the Secured Parties, states as follows:

1. Definitions. The term "Trademark Collateral" shall mean all right, title or interest in to or under all of the following Pledged Collateral of each Grantor (a) all Trademarks of such Grantor listed on Schedule I hereto; and (b) all Proceeds of any and all of the foregoing Capitalized terms used herein without definition are used as defined in the Security Agreement.

2. Release of Security Interest. The Collateral Agent, on behalf of itself and the Secured Parties, hereby terminates the Trademark Security Agreement and the Interests and terminates, releases and discharges the Interests in the Trademark Collateral, and re-assigns to Grantor, any and all other right, title or interest the Collateral Agent or any Secured Party may have in, to or under the Trademark Collateral, together with the goodwill of the business symbolized thereby, without recourse, representation or warranty (either express or implied). Any Interest or other right, title or interest of the Collateral Agent or any Secured Party in such Trademark Collateral shall hereby cease and become void.

The Collateral Agent hereby authorizes the Grantors, or the Grantors' authorized representatives to: (a) record this Termination with the United States Patent and Trademark Office and/or any other applicable governmental office or agency, and (b) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the Interests of the Collateral Agent in the Trademark Collateral. The Collateral Agent agrees to execute and deliver to the Grantors (at the Grantors' expense) and their respective successors, assigns or other legal representatives all other instruments and other documents as may be reasonably requested by the Grantors to release the Interests in the Trademark Collateral which had been granted under the Trademark Security Agreement and Security Agreement.




